



- 3. ALL VERTICAL CONTROLS ARE BASED ON U.S.G.S. DATUM NAVD 88
- 4. ALL PIPE ELEVATIONS ARE INVERT ELEVATIONS UNLESS OTHERWISE NOTED ON PLANS.
- 5. CLEAR ALL UTILITIES BY A MINIMUM OF 12' CLEAR ALL POLES BY 5'-0' MINIMUM, OR TUNNEL AS REGUIRED. THE CONTRACTOR SHALL COORDINATE WITH UTILITY COMPANIES TO SCHEDULE THE BRACING OF THE POLES, IF REQUIRED.



CONSTRUCTION SPECIFICATIONS

1. FENCE POSTS SHALL BE A MINIMUM OF 36' LONG DRIVEN 16" MINIMUM INTO THE GROUND. WOOD POSTS SHALL BE 1x" X 1x" SQUARE (MINIMUM) CUT, OR 1x" DIAMETER (MINIMUM) ROUND AND SHALL BE OF SOUND QUALITY HARDWOOD, STEEL POSTS WILL BE STANDARD T OR U SECTION WEIGHTING NOT LESS THAN 1.00 POND PER LINEAR FOOT.

2. GEOTEXTILE SHALL BE FASTENED SECURELY TO EACH FENCE POST WITH WIRE TIES OR STAPLES AT TOP AND MID-SECTION AND SHALL MEET THE FOLLOWING REQUIREMENTS FOR GEOTEXTILE CLASS F:

TENSILE STRENGTH TEST: MSMT 509 50 LBS/IN (MIN.) TEST: MSMT 509 TENSILE MODULUS 20 LBS/IN (MIN.) 0.3 GAL F12/ MINUTE (MAX.) TEST: MSMT 322 FLOW RATE FILTERING EFFICIENCY 75% (MIN.) TEST: MSMT 322

 WHERE ENDS OF GEOTEXTILE FABRIC COME TOGETHER, THEY SHALL BE OVERLAPPED, FOLDED AND STAPLED TO PREVENT SEDIMENT BYPASS.

4. SILT FENCE SHALL BE INSPECTED AFTER EACH RAINFALL EVENT AND MAINTAINED WHEN BULGES OCCUR OR WHEN SEDIMENT ACCUMES ION REACHED 50% OF THE FABRIC HEIGHT.

REQUIRED SEQUENCE OF CONSTRUCTION

- 1. OBTAIN THE REQUIRED GRADING PERMIT. (7 DAYS)
- 2. NOTIFY MISS UTILITY 48 HOURS BEFORE BEGINNING ANY WORK @ (1-800-257-7777). NOTIFY HOWARD COUNTY CONSTRUCTION INSPECTION DIVISION 24 HOURS BEFORE STARTING ANY WORK @ 410-313-1870 (2 DAYS).
- 3. INSTALL THE REQUIRED SEDIMENT AND EROSION CONTROL DEVICES AS PER THESE DRAWINGS. (2 DAYS)
- 4. THE CONTRACTOR TO INSPECT AND PROVIDE NECESSARY MAINTENANCE ON THE SEDIMENT AND EROSION CONTROL DEVICES SHOWN HEREON, AFTER EACH RAINFALL AND ON A DAILY BASIS. (DURATION OF PROJECT)
- 5. EXCAVATE TRENCHES, CONSTRUCT PIPELINES AS SHOWN ON THE CONSTRUCTION DRAWINGS, KEEPING ALL CONSTRUCTION ACTIVITIES WITHIN THE LIMITS OF DISTURBANCE. ALL TREES SHALL BE PRESERVED AND PROTECTED UNLESS THEY DIRECTLY INTERFERE WITH SEWER AND WATER CONSTRUCTION, (10 DAYS)
- 6. FINE GRADE ALL AREAS DISTURBED BY PIPELINE CONSTRUCTION AND STABILIZE ACCORDING TO RESTORATION SCHEDULES. (2 DAYS)
- 7. FOLLOWING SUCCESSFUL STABILIZATION OF ALL DISTURBED AREAS, AND AFTER PERMISSION HAS BEEN OBTAINED FROM THE HOWARD COUNTY SEDIMENT CONTROL INSPECTOR, REMOVE SEDIMENT CONTROL MEASURES AND STABILIZE REMAINING DISTURBED AREAS WITH PERMANENT SEEDING MIXTURE AND STRAW MULCH.(3 DAYS)

SEDIMENT AND EROSION CONTROL NOTES

- ALL EROSION /SEDIMENT CONTROL MEASURES SHALL COMPLY WITH THE "MARYLAND STANDARD AND SPECIFICATIONS FOR SOIL EROSION AND SEDIMENT CONTROL'BY THE MARYLAND DEPARTMENT OF THE ENVIRONMENT, WATER MANAGEMENT ADMINISTRATION IN ASSOCIATION WITH THE NATURAL RESOURCES CONSERVATION SERVICE AND THE STATE SOIL CONSERVATION COMMITTEE (REFERENCED AS THE 94 STANDARDS AND SPEC'S).
- 2. AREAS THAT HAVE BEEN CLEARED AND/OR GRADED, BUT WILL NOT BE CONSTRUCTED ON OR PERMANENTLY VEGETATED FOR MORE THAN 14 DAYS (7 DAYS FOR STEEP SLOPES) MUST BE STABILIZED WITH MULCH OR TEMPORARY STABILIZATION. ANY AREAS THAT ARE IN TEMPORARY VEGETATION FOR OVER ONE YEAR WILL NEED TO BE PERMANENTLY VEGETATED.
- 3. FOR SPECIFICATIONS ON PERMANENT OR TEMPORARY STABILIZATION SEE SECTION G-20 OF THE 1994 STANDARDS AND SPECIFICATIONS.
- 4. MULCHING CAN ONLY BE USED ON DISTURBED AREAS AS A TEMPORARY COVER WHERE VEGETATION IS NOT FEASIBLE OR WHERE SEEDING GERMINATION CANNOT BE COMPLETED BECAUSE OF WEATHER CONDITIONS. FOR SPECIFICATIONS SEE G-20 SEC. 1- F, G,& H.
- 5. FOR SPECIFICATIONS ON THE STABILIZATION OF CUT AND FILL SLOPES GREATER THAN 3 HORIZONTAL TO 1 VERTICAL, SEE G-20-SEC 1, I & J.
- 6. THE REQUIRED SEQUENCE OF CONSTRUCTION MUST BE FOLLOWED DURING SITE DEVELOPMENT. ANY CHANGES IN THE SECUENCE OF CONSTRUCTIOIN MUST BE APPROVED BY THE SOIL CONSERVATION DISTRICT.
- 7. ANY REVISIONS TO THE SEDIMENT CONTROL PLAN, NOT COVERED UNDER THE LIST OF PLAN MODIFICATIONS THAT CAN BE APPROVED BY THE SEDIMENT CONTROL INSPECTOR, NEED TO BE SUBMITTED TO THE SOIL CONSERVATION DISTRICT FOR APPROVAL.
- 8. NO PROPOSED SLOPE SHALL BE GREATER THAN 2:1.
- 9. ALL SEDIMENT CONTROL STRUCTURES WILL BE INSPECTED ONCE A WEEK AND AFTER EACH RAINFALL AND WILL BE REPAIRED, AS NEEDED, SO THAT THE STRUCTURE MEETS THE MINIMUM SPECIFICATIONS AS SHOWN IN THE 94 STANDARDS AND SPEC'S.
- IØ. THE CONTRACTOR IS RESPONSIBLE FOR MAINTAINING ALL SEDIMENT AND EROSION CONTROL MEASURES UNTIL THE DISTURBED AREAS ARE PERMANENTLY STABILIZED.

11. THE OISTRICT APPROVAL FOR THIS SEDIMENT CONTROL PLAN IS GOOD FOR 2 YEARS. AT THE FND OF 2 YEARS, IF CONSTRUCTION OF THE PLAN HAS NOT STARTED, THE PLAN WILL NEED TO BE RESUBMITTED TO THE SOIL CONSERVATION DISTRICT FOR REVIEW AND RE- APPPROVAL. SCOPE: PLANTING PERMANENT, LONG LIVED VEGETATIVE COVER ON GRADED AND/OR CLEARED AREAS AND AREAS THAT HAVE BEEN IN TEMPORARY VEGETATION FOR MORE THAN 1 YEAR. STANDARDS: THE FOLLOWING NOTES SHALL CONFORM TO THE "1994 MARYLAND STANDARDS AND SPECIFICATIONS FOR EROSION AND SEDIMENT CONTROL* PUBLISHED JOINTLY BY THE MARYLAND DEPARTMENT OF ENVIRONMENT- WATER MANAGEMENT ADMINISTRATION, THE NATIONAL RESOURCES CONSERVATION SERVICE, AND THE STATE SOIL CONSERVATION COMMITTEE.

THE SEED BED SHALL BE PREPARED BY LOOSENING THE SOIL TO A DEPTH OF 3 TO 5 INCHES AND INCORPORATING THE LIME AND FERTILIZER INTO THIS LOOSENED LAYER OF SOIL. SEE G-20 SEC. 1- C.

FOR SITES OF 5AC. OR LESS OF DISTURBANCE, THE FOLLOWING FERTILIZER AND LIME RATES SHALL APPLY, FERTILIZER SHALL CONSIST OF A MIXTURE OF 10-20-20 AND BE APPLIED AT THE FOLLOWING RATES: N=90 LB PER ACRE (2 L8 PER 1000SO. 
