CONDITIONS WHERE PRACTICE APPLIES

THIS PRACTICE SHALL BE USED ON DENUDED AREAS AS SPECIFIED ON THE PLANS AND MAY BE USED ON HIGHLY ERODIBLE OR CRITICALLY ERODING AREAS. THIS SPECIFICATION IS DIVIDED INTO TEMPORARY SEEDING, TO QUICKLY ESTABLISH VEGETATIVE COVER FOR SHORT DURATION (UP TO ONE YEAR), AND PERMANENT SEEDING, FOR LONG TERM VEGETATIVE COVER. - SOIL TESTS MUST BE PERFORMED TO DETERMINE THE EXACT RATIOS AND APPLICATION RATES FOR BOTH LIME AND FERTILIZER ON SITES HAVING DISTURBED AREAS OVER 5 ACRES.  THE SOIL SHALL CONTAIN LESS THAN 40CLAY, BUT ENOUGH FINE GRAINED MATERIAL 030% SILT PLUS CLAY) TO PROVIDE THE CAPACITY TO HOLD A MODERATE AMOUNT OF MOISTURE. AN EXCEPTION IS IF LOVEGRASS OR SERECIA LESPEDEZAS IS TO BE PLANTED, THEN A SANDY SOIL (30% SILT PLUS CLAY) WOULD BE
- SOIL SHALL CONTAIN 15% MINIMUM ORGANIC MATTER BY WEIGHT. SOIL MUST CONTAIN SUFFICIENT PORE SPACE TO PERMIT ADEQUATE ROOT PENETRATION.




